12. Provide an update on progress made in implementing and/or operating the approved 1332 waiver.

(1) Legislative Update. The Montana Commissioner of Securities and Insurance (CSI) proposed two legislative changes to the state-based statues governing the Montana Reinsurance program (House Bill 63) in its 2021 legislative session, both of which were enacted into law with an effective date of July 1, 2021; see below:

• Section 33-22-1316(5), MCA. The disbursement date for reinsurance payments will be changed from August 15 to December 31 of the year following the applicable benefit year.

• Section 33-22-1313(5), MCA. The federal citation will be changed from 45 CFR 158.221 to 45 CFR 152.232(f), such that the calculation of an insurer's medical loss ratio will be based on a single year of experience, without applying any credibility assessment.

(2) Operational Expenses. Since January 2021 the reinsurance program has only incurred operational expenses. All expenses have been paid from draws on the federal grant. Please see the attached operational report dated 3/31/2021 for more details.

(3) Claims Submission & Reimbursement. Claims incurred in 2020 (the first year of operation of the reinsurance program) will be submitted for reimbursement in 2021. The Reinsurance Board recently

established:

- Cut-off date for claims that are incurred during 2020 (to be allocated to 2020): June 30, 2021
- Submission date of claims for reimbursement: August 15, 2021
- Reimbursement date of claims: On or before December 31, 2021
